**Admission/Readmission Tracking: What Are the Requirements for Various Admission and Readmission Scenarios to Ohio Medicaid Certified NF's?**

**This course contains information which is similar to the knowledge provided in our PASRR/LOC class. Like that class, it also includes information on all of the new Ohio PASRR Rules that became effective 12/1/09. The focus here is specific to the details on the requirements for four types of Admission/Readmission to Ohio Medicaid certified Nursing Facilities. They include;**

- 1. Admissions/Readmissions from the Community (Home, Apartment, Assisted Living Facility, Hospital Emergency Room,etc)**
- 2. Admissions from the Community to the Hospital and then to a Medicaid Certified NF**
- 3. Admission from one Medicaid certified NF to another Medicaid certified NF (Directly or via the Hospital)**
- 4. Admissions from Out of State to Ohio NF**

**An Admission/Readmission tracking record for each scenario is examined. In addition, each admission and readmission scenario is explained in paragraph form.**
