

**Directions to Aberdeen Community Center**

**From I-271.**

**Exit at Wilson Mills Road / Highland Heights (exit 36). Turn west onto Wilson Mills Road and travel approximately ¼ mile to Miner Road (US BANK on corner). Turn right onto Miner Road and travel to second traffic light. Aberdeen Community will be on your left. Turn left into Aberdeen (Aberdeen Blvd.) and the entrance to Community Center will be approximately one half mile on your right (Next to the pool)**

**The following drive way is the entrance to the golf course**

**From I-90.**

**Exit at Bishop Road / Wickliffe (exit 187). Turn South onto Bishop Road and travel approximately 4 miles (you will pass the Cuyahoga County Airport on the right). Aberdeen Community will be on your left. Turn left into Aberdeen (Aberdeen Blvd.) and the entrance to the Community Center be approximately 7/10 mile on your left (The first drive is entrance to the golf**

**Course Description**

This seminar will explore the challenges of various PASRR (Preadmission Screening/Resident Review) scenarios. PASRR is the process by which Preadmission Review screens individual applicants for indications of serious mental illness and/or mental retardation or developmental disabilities prior to admission to Medicaid certified NF's (Nursing Facilities). It is required for all admissions to Medicaid certified NF's regardless of the individual's payment source. PASRR is a federal mandate from the OBRA 1987 nursing home reform act. Every state must implement the PASRR process. The law specifies that as of 1/1/1989, NF's must not admit any individual who triggers the PASRR screen (also known as ODJFS 3622) for mental illness and/or mental retardation/developmental disorder without an approval from the appropriate state authorities.

**Course Objectives**

1. Present 10 different PASRR/LOC Topics based on scenarios and Q&A.
2. Discuss recent changes to the Ohio PASRR process.
3. Analyze material which helps participants think logically and creatively. Assist PASRR professionals with the integration of different experiences and knowledge when it comes to dealing with everyday PASRR/LOC situations.
